Assembling the equipment

Assemble the high-pressure cleaner as shown in Fig. 2-7.

Water inlet connector (Fig. 1/13)

The connection for the water inlet (13) is equipped with a connector for standard hose coupling systems. Remove the transport cap (fig.5) and attach the hose coupling on the supply hose (min. Ø 1/2") to the connector for the water inlet (13).

An anti-vacuum device must be installed between the water tap and the high-pressure cleaner! Ask your local plumber about this.

Connecting the high-pressure hose (Fig. 1-2; 5-6/18)

Remove the transport cap as shown in Fig. 5 from the connection for the high-pressure hose (9). Connect the high-pressure hose (18) to the connection on the high-pressure cleaner (9) (Fig. 6) and on the spray gun (14) (Fig. 2).

Fitting the gun attachments

The normal lance, the lance with rotating nozzle or the foam nozzle can be attached prior to using the high-pressure cleaner (Fig. 2).

Lance point / wide cone (16)

The shape of the water jet can be changed from concentrated to flat jet by turning the nozzle (Fig. 9).

Lance with rotating nozzle (17)


To remove particularly stubborn dirt, use the lance with rotating nozzle (17).


Electrical connections (Fig. 1)


- Before you connect the appliance to the mains supply make sure that the data on the rating plate is identical to the mains data.
- If you use any extension cables, make sure that they are suitable for outdoor use and have large enough wires:


1 – 10m: 1.5 mm² 10 – 30m: 2.5 mm²


 Plug the mains plug (8) on the power cable (6) into the mains socket outlet.














Proper use

The high-pressure cleaner is designed to clean vehicles, machines, buildings, facades, etc. in the private sector.

The equipment is to be used only for its prescribed purpose. Any other use is deemed to be a case of misuse. The user / operator and not the manufacturer will be liable for any damage or injuries of any kind caused as a result of this.

Please note that our equipment has not been designed for use in commercial, trade or industrial applications. Our warranty will be voided if the machine is used in commercial, trade or industrial businesses or for equivalent purposes.



Warning! High-pressure jets can be dangerous if not used properly. Do not direct the jet at persons, animals, live electrical equipment or the unit itself.

Before putting the machine into operation

Correctly using the device

- The high-pressure cleaner must be set on a level, stable surface.
- It is recommended that you maintain the correct operating position every time you use the machine by placing one hand on the pistol and the other on the lance.
- Never direct the water jet toward electrical lines or the machine itself
- It is normal for the pump to leak a little; this is necessary to avoid damage to the pump when it is at a standstill.
- Never use the equipment in potentially explosive areas under any circumstances!
- The operating temperature must be between +5 and + 60°C.
- Do not cover or modify the lance or the spray nozzles in any way.
- The high-pressure cleaner is designed to be used with cold or lukewarm water (max. 60°C); higher temperatures can damage the pump.
- Do not use water that is dirty, gritty or contains any chemical products, as these could impair operation and shorten the life of the equipment.
- When using the pressure washer, we recommend you wear safety goggles to guard your eyes from flying debris/water spray.

Instructions 4

Operation

The equipment consists of an assembly with a pump, which is encased in a shock absorbing housing. The equipment comes with a lance and a non-slip gun (for an optimal working position), whose shape and configuration comply with the applicable regulations.

Using for the first time

Once you have completely assembled the high-pressure cleaner and connected all connections, proceed as follows:

Turn on the water inlet supply. Press safety pin "a" (Fig. 2) on the spray gun and pull back trigger lever "b" (Fig. 2) in order to bleed the trapped air out of the device.

Turn on the device by switching the ON/OFF switch (Fig. 1/12) to "I".

To temporarily turn off, release the trigger lever (b), at which point the device goes to standby. As soon as you press the trigger lever again (b), the high-pressure cleaner restarts.

To completely turn off the high-pressure cleaner, switch the ON/OFF switch (Fig. 1/12) to "0".

Using cleaning agent (Fig. 2;7)

Unscrew and remove the foam nozzle (7) from the cleaning agent tank (15) (Fig. 7). Fill a suitable cleaning agent into the cleaning agent tank (15) and replace the foam nozzle (7). Fit the foam nozzle (7) to the pistol (14) as shown in Fig. 2. The cleaning agent will be added automatically.

Holder for the gun/accessories (Fig. 1;8)

The gun and accessories can be kept in the provided holder (10) (Fig. 8) in order to save space when not in use.

Cleaning, maintenance and ordering of spare parts

Important! Always pull out the mains power plug before starting any cleaning work.

Cleaning

- Keep all safety devices, air vents and the motor housing free of dirt and dust as far as possible. Wipe the equipment with a clean cloth or blow it with compressed air at low pressure.
- We recommend that you clean the device immediately each time you have finished using it.
- Clean the equipment regularly with a moist cloth and some soft soap. Do not use cleaning agents or solvents; these could attack the plastic parts of the equipment. Ensure that no water can seep into the device.

Maintenance

Checking the water intake filter (Fig. 10-11/19)

Periodically check the intake filter in order to prevent clogging, which could jeopardize operation of the pump.

To do this, unscrew the connection coupling for the water inlet hose from the device and clean the exposed inlet sieve by placing it under running water. Then re-fit the filter and connection coupling.

Long periods of non-use (electric pump)

If the machine is going to be stored for longer periods of time (i.e. over 3 months) in a room where frost could develop, it is recommended that the machine be filled with an antifreeze solution (similar to the antifreeze solutions used for vehicles).

When the device is not used for an extended period of time, lime deposits begin to form in the electric pump, which in turn can lead to starting difficulties.

Cleaning the nozzle (Fig. 12)

Use the supplied wire (A) to clean clogged nozzles.

FAULT	POSSIBLE CAUSES	TROUBLESHOOTING
Device does not work	No electrical voltage at the device	Check the fuse, power cable and power plug and have them replaced by qualified personnel if necessary
	Cross section of the extension cable not large enough and/or the extension cable is too long	Use extension cables with larger cross sections and/or use shorter extension cables
	The mains voltage is lower than that specified	Contact the power supply company if necessary
	The pump is frozen	Check and thaw if necessary
The motor starts but there is no build up of pressure	The water intake filter is clogged	Clean the water intake filter (see 7.2.1)
	Air intake in the water inlet	Check the supply hose and hose connection and replace if necessary
	Discharge nozzle is too large	Check and replace if necessary
Irregular operating pressure	Air intake in the water inlet	Check the supply hose and hose connection and replace if necessary


