1. Safety regulations

General safety information for power tools This tool is not intended to be used by children, persons with reduced physical, sensory or mental capacities or with a lack of experience and knowledge, or persons who are not familiar with the instructions. Children must always be supervised in order to ensure that they do not play with the tool. Children are not allowed to carry out cleaning or maintenance.

If the tool's power cable becomes damaged, it must be replaced by the manufacturer, by one of its customer service centers or by a similarly trained person in order to prevent hazards.

The tool is not allowed to be used at altitudes higher than 2000 m.

Danger!

Read all safety regulations and instructions. Any errors made in following the safety regulations and instructions may result in an electric shock, fire and/or serious injury. Keep all safety regulations and instructions in a safe place for future use.

The term "electric tool" used in the safety instructions refers to electric tools operated from the mains power supply (with a power cable) and to battery operated electric tools (without a power cable).

1. Workplace safety

- Keep your work area clean and well illuminated. Untidy or unlit work areas can result in accidents.
- b) Do not operate the electric tool in an environment where there is a risk of explosions and where there are inflammable liquids, gases or dust. Electric tools produce sparks which could set the dust or vapours alight.
- c) Keep the electric tool out of the reach of children and other persons. If there is a distraction, you may lose control of the appliance.

2. Electrical safety

- a) The connector plug from this electric tool must fit into the socket. The plug should never be altered in any way. Never use adapter plugs together with earthed electric tools. Unaltered plugs and correct sockets reduce the risk of an electric shock.
- b) Avoid bodily contact with earthed surfaces such as pipes, heating, ovens and fridges. The risk of electric shock is increased if your body is earthed.
- c) Keep the tool out of the rain and away from moisture. The ingress of water into an electric tool increases the risk of an electric shock.
- d) Do not use the cable to carry the electric tool, to hang it up or to pull it out of the socket. Keep the cable away from heat, oil, sharp edges and moving parts of the appliance. Damaged or entangled cables increase the risk of an electric shock.
- e) If you are working outdoors with an electric tool, only use extension cables which are designed specifically for this purpose. Using specially designed outdoor extension cables, the risk of electric shock is reduced.
- f) If operation of the electric tool in a damp environment can not be avoided, use a earth-leakage circuit-breaker. The earthleakage circuit-breaker reduces the risk of an electric shock.

3. Safety of persons

- a) Be careful, watch what you are doing and use an electric tool sensibly. Do not use the tool if you are tired or under the influence of drugs, alcohol or medication. A moment of inattention when using the electric tool can result in serious injuries.
- b) Wear personal protection equipment and always wear safety goggles. Wearing personal protection (such as dust masks, non-slip safety shoes, safety helmet or ear protection, depending upon the type and use of the electric tool) reduces the risk of injury.
- c) Make sure that the appliance cannot start up accidentally. Ensure that the electric tool is switched off before you connect it to the power supply and/or insert the battery, or pick up or carry the tool. If your finger is on the switch whilst carrying the electric tool or if you connect the appliance to the mains when it is switched on, this can lead to accidents.
- d) Remove keys and wrenches before switching on the electric tool. A tool or key which comes into contact with rotating parts of the appliance can lead to injuries.
- e) Avoid abnormal working postures. Make sure you stand squarely and keep your balance at all times. In this way, you can control the electric tool better in unexpected circumstances.
- f) Wear suitable work clothes. Do not wear loose clothing or jewellery. Keep hair, clothes and gloves away from moving parts. Loose clothing, jewellery or long hair can get trapped in moving parts.
- g) If vacuuming devices and draining devices can be fitted, make sure that these are correctly attached and correctly used. The use of a dust extraction system can reduce the danger posed by dust.

4. Usage and treatment of the electric tool

- a) Do not overload the appliance. Use the correct tool for your work. You will be able to work better and more safely within the given performance boundaries.
- b) Do not use an electric tool with a defective switch. An electric tool that cannot be switched on or off is dangerous and must be repaired.
- c) Pull the plug out of the socket and/or remove the battery before making any adjustments to the appliance, changing accessories or putting the appliance

down. This safety measure prevents starting the electric tool unintentionally.

- d) Keep unused electric tools out of the reach of children. Do not allow people who are not familiar with the appliance or who have not read these instructions to use the appliance. Electric tools are dangerous if they are used by inexperienced people.
- e) Clean your electric tool carefully. Check whether moving parts are functioning properly and not jamming, whether parts are broken or damaged enough that the functioning of this electric tool is affected. Have damaged parts repaired before using the appliance. Many accidents are caused by badly maintained electric tools.
- f) Keep your cutting tools sharp and clean. Carefully maintained cutting tools with sharp cutting edges will jam less and are easier to control.
- g) Make sure to use electric tools, accessories, attachments, etc. in accordance with these instructions. Take the conditions in your work area and the job in hand into account. Using electric tools for any purpose other than the one for which they are intended can lead to dangerous situations.

5. Service

a) Have your electric tool repaired only by trained personnel using only genuine spare parts. This will ensure that your electric tool remains safe to use.

Safety information for grass trimmers

Instruction requirements

- Read the operating instructions carefully.
 Familiarize yourself with the operator controls and proper use of the grass trimmer.
- b) Never allow persons who are not familiar with these operating instructions or children to use the tool. The age of the user might be restricted by locally applicable regulations.
- c) Always keep in mind that the user of the tool is personally responsible for accidents or hazards involving other persons or their property.

Preparations

 a) Before use, the power cable and extension cable must be checked for signs of damage or wear. If the cable becomes damaged during use, it must be disconnected immediately from the power supply. DO

GB

NOT TOUCH THE CABLE BEFORE IT IS DISCONNECTED FROM THE POWER SUPPLY. Do not use the tool if the cable is damaged or worn.

- b) Before use, the tool must be checked visually for damaged, missing or wrongly fitted safety devices or covers.
- c) Never use the tool when there are people particularly children or pets nearby.

Operation

- a) Keep the power cable and extension cable away from the cutting unit.
- b) Eye protection, long trousers and sturdy shoes must be worn throughout the time spent using the tool.
- c) Avoid using the tool in bad weather conditions, particularly when there is a risk of lightning.
- d) Use the tool only in broad daylight or in well-lit conditions.
- Never use the tool with a damaged cover or safety device or when a cover or safety device is missing.
- f) Switch on the motor only when there are no hands or feet within range of the cutting unit.
- g) Always disconnect the tool from the power supply (i.e. pull the power plug out of the power socket):
 - 1) each time the tool is left unattended;
 - 2) before you clear a blockage;
 - 3) before you inspect, clean or work on the tool
 - 4) after the tool strikes a foreign body;5) whenever the tool begins to make unusual vibrations.
- h) Beware of injuries to feet and hands caused by the cutting unit.
- i) Always make sure that the air vents are kept free of foreign bodies.

Maintenance and storage

- a) Disconnect the tool from the power supply (i.e. pull the power plug out of the power socket) before you carry out any maintenance or cleaning work on it.
- b) Use only spare parts and accessories which are recommended by the manufacturer.
- c) The tool must be inspected and serviced regularly. Have the tool repaired only in an authorized workshop.
- d) When the tool is not being used it must be kept out of children's reach.

Recommendation

The tool should be supplied with a trip current of no more than 30 mA via a residual current protective device (RCD).

Never replace the non-metal cutting unit with a metal cutting unit.

Risk of injury from dangerous moving parts!

Take care to avoid abnormal working postures and to always keep your balance so that you stand squarely on inclines at all times. Walk, don't run.

Take care not to touch moving hazardous parts before the tool has been disconnected from the mains connection and the moving hazardous parts have come to a complete standstill.

Before use, the power cable or the extension cable must be checked for signs of damage or wear. If the power cable becomes damaged during use, disconnect the cable immediately from the power supply. Under no circumstances are you allowed to touch the cable before it is separated from the power supply.

Never connect a damaged power cable to the power supply, and never touch a damaged cable before it has been disconnected from the power supply – damaged cables might result in you touching active parts.

Keep extension cables away from dangerous moving parts in order to prevent damage to cables that might result in you touching active parts.

Avoid using the tool in poor weather conditions, especially if there is a risk of lightning.

When working outdoors, use only extension cables which are approved for outdoor use. Extension cables must have a minimum cross-section of 3 x 0.75 mm^2 and are not allowed to be of a lighter duty class than H05RN-F Extension cables are not allowed to exceed a maximum length of 50 m. Plug connections must have earthing contacts and be protected from rainwater.

Additional safety instructions

- Before you begin your work, examine the material you want to cut. Remove any foreign bodies. Continue to watch out for foreign bodies while you are working. If you come across any foreign bodies while cutting, turn off the machine and remove the items in question.
- Work only when visibility is adequate.
- Make sure you stand squarely at all times while working. Be careful when walking backwards. Tripping hazard!
- Never leave the equipment unsupervised in the work area. If you stop work for a while, leave the equipment in a safe place.
- If you stop your work in order to go to another area to work, you must make sure that the equipment is switched off while you are going there.
- Never use the equipment while it is raining or in damp or wet surroundings.
- Protect your equipment against moisture and rain.
- Before you switch on the equipment, check that the cutting unit will not touch any stones or other objects.
- Always wear suitable working clothes to prevent injuries to the head, hands and feet. For this purpose wear a helmet, safety goggles (or visor), high boots (or strong shoes and long trousers made of tough fabric) and work gloves.
- When the equipment is in operation, you must always hold it away from your body!
- Do not switch on the equipment when it is turned around or when it is not in working position.
- Switch off the machine and pull out the power plug: when the equipment is not being used, when you leave it unsupervised, when checking the equipment, when removing or replacing the spool, or when transporting the equipment from one place to another.
- Keep the equipment away from other people, especially children, and from pets. There may be stones and other objects in the grass that is cut and thrown up.
- When you are working, keep a distance of at least 5 m from other persons and pets.
- Do not cut against hard objects. This will help you to prevent causing injury to yourself and damage to the equipment.
- Use the edge of the safety guard to keep the equipment away from walls, different surfaces and fragile objects.
- Never use the equipment without the safety

guard.

- This equipment is not allowed to be used by children or by persons with reduced physical, sensory or mental capacities or those with a lack of experience and knowledge. Children should be supervised so that they do not play with the equipment. Children are not allowed to carry out the cleaning or maintenance.
- Avoid abnormal working postures. Make sure you stand squarely and keep your balance at all times. Always maintain good footing on inclines. Only operate the equipment at a walking pace.
- Risk of injury from dangerous moving parts!
- The moving parts are not allowed to be touched before the power plug has been removed and all moving parts have come to a complete standstill.
- Read the directions with due care. Familiarize yourself with the operator controls and proper operation of the equipment.
- Never allow children or other persons who are not familiar with the operating instructions to use the equipment. Contact your local governmental agency for information regarding minimum age requirements for the user.
- Always keep in mind that the user of the equipment is personally responsible for accidents or hazards involving other persons or their property.
- Before use, always carry out a visual check to make sure that the safety devices or covers are not missing or damaged and that they are correctly fitted.
- Never use the equipment in bad weather conditions and particularly never when there is a risk of lightning.
- Never use the equipment with a damaged cover or safety device or when a cover or safety device is missing.
- Switch on the motor only when there are no hands or feet within range of the cutting unit.
- Always switch off the equipment and pull out the power plug:
 - when the equipment is left unattended
 - before you remove a blockage
 - before you inspect, clean or work on the equipment
 - after the equipment strikes a foreign body - when the equipment begins to make unusual vibrations (examine immediately) The equipment is not allowed to be put into operation again until the cause of the unusual vibrations is eliminated. If you fail to find the cause of the vibrations, contact a service center.

- Risk of injury from the cutting unit! Keep hands and feet away from the cutting unit!
- Use only spare parts and accessories which are recommended by the manufacturer.
- Examine and service the equipment regularly.

Important! The safety guard is there to ensure your safety and the safety of others. It is also essential for the equipment to work correctly. Failure to comply with this instruction will invalidate your warranty as well as create a potential source of danger.

- Never use your hands to try to stop the cutting unit. Always wait for it to stop by itself.
- Use only genuine cutting units.
- Make sure that the air vents are free of dirt.
- Do not try to use the equipment to cut grass which is not growing on the ground; for example, do not try to cut grass growing on walls or stones, etc.
- The person operating the grass trimmer is liable for any damages sustained by third parties within the equipment's working radius as a result of its use.
- Do not cross roads or gravel paths with the equipment switched on.
- When you are not using the equipment, keep it in a dry place out of the reach of children.
- Use the equipment only in the way described in these operating instructions and always hold it perpendicular to the ground. Every other position is dangerous.
- Check at regular intervals that the screws are properly tightened.
- The area to be cut must always be kept cleared of cables and other objects.
- If the equipment has to be lifted for transporting, be sure to switch off the motor first and wait for the cutter to come to a standstill. Each time you leave the equipment, switch off the motor.
- Under no circumstances are you to cut against hard objects during use. This is imperative to prevent injury to yourself and damage to the equipment.
- Use only original replacement parts for repairs.
- Before starting up the equipment, and after any collision, check the equipment for signs of wear or damage and have any necessary repairs carried out.
- Always keep your hands and feet away from the cutting unit, especially when switching the motor on.
- Pull out the power plug before checking,

cleaning or doing any work on the equipment and when it is not being used.

- Acquaint yourself with the controls and how to use the tool.
- Stop using the equipment when there are people – particularly children – or pets nearby.
- Never use the machine if protective equipment is damaged or missing.
- Never mount metal cutting elements.
- Electrically powered trimmers should be repaired only by authorized persons.
- Use only spare parts and accessories which are recommended by the manufacturer.
- Before use, you must check the power cable and extension cable for signs of damage and wear.
- Keep the power cable and the extension cable away from the cutting unit.
- If the cable is damaged during operation, it must be disconnected immediately from the power supply. Do not use the machine if the power cable is damaged or worn.
- Never connect a damaged power cable to the power supply or touch a damaged cable before it has been disconnected from the power supply – damaged cables might result in you touching active parts.
- Keep extension cables away from dangerous moving parts in order to prevent damage to cables that might result in you touching active parts.
- The machine should be supplied with a trip current of no more than 30mA via a residual current protective device (RCD).

Important: The cutting unit continues to run for a few seconds after the motor is switched off.

The cutter continues to rotate!

3. Proper use

The equipment is designed for cutting lawns and small areas of grass in private and hobby gardens.

Equipment designed for use in private and hobby gardens is regarded as unsuitable for use in public facilities, parks and sports centers, along roadways, or in agriculture and forestry. The operating instructions as supplied by the manufacturer must be kept and referred to in order to ensure that the equipment is properly used and maintained.

Important. This equipment must not be used for composting purposes (shredding) as this could result in injury or damage to property.

The equipment is to be used only for its prescribed purpose. Any other use is deemed to be a case of misuse. The user / operator and not the manufacturer will be liable for any damage or injuries of any kind caused as a result of this.

Please note that our equipment has not been designed for use in commercial, trade or industrial applications. Our warranty will be voided if the machine is used in commercial, trade or industrial businesses or for equivalent purposes.

- Switch the appliance off when it is not in use.
- Wear protective gloves.

Caution!

Residual risks

Even if you use this electric power tool in accordance with instructions, certain residual risks cannot be rules out. The following hazards may arise in connection with the equipment's construction and layout:

- 1. Lung damage if no suitable protective dust mask is used.
- 2. Damage to hearing if no suitable ear protection is used.
- 3. Health damage caused by hand-arm vibrations if the equipment is used over a prolonged period or is not properly guided and maintained.

5. Before starting the equipment

Before you connect the equipment to the mains supply make sure that the data on the rating plate are identical to the mains data.

Warning!

Always pull the power plug before making adjustments to the equipment.

5.1 Assembling the grass trimmer (Fig. 3a and 3c)

- Mount the safety guard on the motor head
 - (see Fig. 3a).
- Then fix the safety guard with 2 screws (1.).
- Finally, secure the edge guide with the last two screws (2.) (see Fig. 3b).

5.2 Adjusting the additional handle (Fig. 4)

Place the electric grass trimmer on a firm surface. Slacken the screw (Fig. 5/Item A) and move the additional handle to its optimal position. Lock the handle in place by tightening the screw.

5.3 Height adjustment (Fig. 4)

Place the electric grass trimmer on a firm surface. First loosen the height adjuster (Fig. 4/Item 6). Then set the required length and retighten the height adjuster.

5.4 Adjusting the angle of the handlebar (Figure 5)

When the lock is pressed (Fig. 5/Item 15) you can adjust the angle of the handlebar to 5 positions. Set the angle which is best suited for your work. Make sure that there is an audible click when the handlebar engages.

6. Operation

The electric grass trimmer is designed only to cut grass.

The electric grass trimmer has a fully automatic line extension system. If the line of the electric grass trimmer is reduced through operation, it is automatically extended to the maximum cutting width. This ensures that you can cut your lawn with the perfect cutting width at all times.

Caution! If the line is too long when you use the equipment for the first time, the surplus end of it will be cut by the blade on the guard hood.

Your grass trimmer will work at its best if you observe the following instructions:

- Never use the grass trimmer without its safety devices.
- Do not cut grass when it is wet. The best results are had on dry grass.
- Connect the power cable to the extension cable and fasten this to the strain-relief clamp (Figure 6/Item 13).
- To switch on your grass trimmer, press the ON/OFF switch (Fig. 6/Item 3).
- To deactivate the grass trimmer, let go of the On/Off switch (Figure 6 / Item 3).
- Do not move the grass trimmer against the grass until the switch is pressed, i.e. wait until the trimmer is running.
- For the correct cutting action, swing the grass trimmer to the side as you walk forward, holding it at an angle of approx. 30° as you do so (see Figure 7 and Figure 8).
- Make several passes to cut long grass shorter step by step from the top (see Figure 9).
- Use the edge guide and the guard hood to prevent unnecessary wear on the line.
- Keep the grass trimmer away from hard objects in order to avoid unnecessary line wear.

Using the grass trimmer as an edge trimmer (Fig. 12/13)

To cut the edges of lawns and flower beds, the grass trimmer can be converted as follows:

- Switch off the power supply of the electric grass trimmer.
- Pull the sleeve (Fig. 12/Item 10) to the rear.
- Hold the sleeve in the rear position and rotate the top handle through 180° (Fig. 12) until it latches in place.

• Now you have converted the electric grass trimmer to an edge trimmer for cutting the lawn vertically (Fig. 13).

7. Replacing the power cable

Danger!

If the power cable for this equipment is damaged, it must be replaced by the manufacturer or its after-sales service or similarly trained personnel to avoid danger.

8. Cleaning, maintenance and ordering of spare parts

Danger!

Always pull out the mains power plug before starting any cleaning work.

8.1 Cleaning

- Keep all safety devices, air vents and the motor housing free of dirt and dust as far as possible. Wipe the equipment with a clean cloth or blow it with compressed air at low pressure.
- We recommend that you clean the device immediately each time you have finished using it.
- Clean the equipment regularly with a moist cloth and some soft soap. Do not use cleaning agents or solvents; these could attack the plastic parts of the equipment. Ensure that no water can seep into the device. The ingress of water into an electric tool increases the risk of an electric shock.
- Use a brush to remove deposits from the safety guard.

8.2 Replacing the line spool (Fig. 14-16) Important! Make sure that you pull out the power plug before replacing the line spool!

- Press the sides of the spool cover as shown and remove the cover (Figure 14-15).
 - Remove the empty line spool.
- Thread the ends of the line on the new line spool through the eyelets in the spool receptacle (Fig. 16).
- Fit the spool cover back in the spool mount.
- When you start the equipment again the line will be cut to the perfect length automatically.
 Caution! Bits of the nylon line could cause injury when flung out!

9. Disposal and recycling

The equipment is supplied in packaging to prevent it from being damaged in transit. The raw materials in this packaging can be reused or recycled. The equipment and its accessories are made of various types of material, such as metal and plastic. Never place defective equipment in your household refuse. The equipment should be taken to a suitable collection center for proper disposal. If you do not know the whereabouts of such a collection point, you should ask in your local council offices.

10. Storage

Store the equipment and accessories out of children's reach in a dark and dry place at above freezing temperature. The ideal storage temperature is between 5 and 30 °C. Store the electric tool in its original packaging.

11. Troubleshooting

The machine will not work:
